Our theme, "Refugia of the Blue Mountains," invites artists to explore the wildlands, rivers, and resilient ecosystems that serve as havens for biodiversity amid climate change. The program offers artists a unique opportunity to create work that bridges the gap between art and environmental conservation, highlighting the beauty and importance of refugia in Northeast Oregon.

The selected artist will receive a \$2,000 stipend, a 10-day residency at <u>Good Bear</u>

Ranch, and support from GHCC to showcase their work at a fall 2025 event in La Grande.

Comments on Morgan Nesbit due December 19th

The public comment period has opened for Morgan Nesbit, a large logging project between the Eagle Cap Wilderness and Hells Canyon Wilderness. Many of you have provided comments during scoping (thank you!) and the agency seemed to listen seriously to concerns about protecting habitat connectivity. While we are happy to see that change, we still have concerns and need to look deeper into the scale and extent of planned fuel breaks and units in Riparian Habitat Conservation Areas. Look for additional information from us and opportunities to comment on this soon.

<u>Despite Biden's promise to protect old forests, his administration keeps</u> approving plans to cut them down

Despite President Biden's 2022 executive order to protect mature and old-growth forests, the Bureau of Land Management (BLM) has continued to approve logging projects. An analysis by Oregon Public Broadcasting and ProPublica found that under the Biden administration, the BLM is on track to log approximately 47,000 acres of public lands nearly the same amount as during the first Trump presidency.
