Senator Merkley's Virtual Environmental Town Hall

Mark your calendar for Tuesday, October 8th, 3:30pm PT to attend a virtual town hall with Senator Jeff Merkley, organized by OLCV. He will be giving updates on his environmental priorities and how climate investments of the 2021 Bipartisan Infrastructure Law and Inflation Reduction Act will benefit Oregon.

If you get a chance to ask a question please consider the following topics:

- Right now two major Oregon forest plans are being revised the Northwest Forest
 Plan and the Blue Mountains Forest Plan. What conservation safeguards is the
 Senator hoping to see enacted to protect the last of our big, climate change fighting
 trees, and to prevent fragmentation of the limited undeveloped lands from road
 building and destructive logging practices?
- Oregon's salmon and orcas are in decline and don't have time to waste! Will the Senator support removal of the Lower Four Snake River Dams by the end of this decade?
- Right now there are opportunities at both the federal and state levels to construct wildlife crossing infrastructure (over and underpasses, fencing, etc). What is the Senator doing to support these efforts?

GHCC at Great Old Broads for Wilderness Conference

<u>Great Old Broads for Wilderness</u> is hosting their <u>Wilderness & Beyond Conference</u> in Este Park Colorado, October 14-17. Emily will represent GHCC, highlighting the importance of the Blue Mountains and the Greater Hells Canyon Region to the national audience attending on two panels.

The first is on forest planning revision processes currently happening on National Forests across the West (a seemingly never ending process in the Blue Mountains!). The panel will talk about the general process under the "new" 2012 planning rule and highlight our own Blue Mountains Forest Plan and the Northwest Forest Plan. We'll discuss the ramifications of these plans for decades to come based on what management activities are or are not allowed in these overarching plans. For example, the current rule protecting trees over 21" in diameter is on the chopping block.

The second panel is on Senator Wyden's River Democracy Act legislation. With reintroduction earlier this summer we are hopeful that these critical waterways around our state are acknowledged and given helpful Wild & Scenic River status to protect for the important conservation and/or recreation values they offer.

Other news we're following...

<u>US Forest Service puts seasonal hiring on hold, affecting hundreds of temporary Northwest jobs</u>

The U.S. Forest Service has paused its seasonal hiring for 2025, impacting temporary jobs in Oregon and Washington next summer, except for fire-related roles. This decision stems from budget constraints, which will affect positions such as trail building and engineering, and may result in noticeable changes to forest maintenance and services during the summer months.

Biden administration is taking steps to eliminate protections for gray wolves

The Biden administration has requested the reinstatement of a Trump-era rule that removed Endangered Species Act protections for gray wolves. If successful, it would place wolves under state oversight and allow hunting to resume in some regions. Environmental groups argue this could reverse progress in wolf population recovery.

<u>Oregon House Republicans target forests for wildfire reform as grass and</u> shrubland burns

Oregon House Republicans are pushing for wildfire reform efforts that focus on forest management, despite recent fires primarily burning grass and shrublands. They argue that more proactive measures are needed in forests to prevent larger, catastrophic fires, even as environmentalists caution against over-emphasizing forest treatments at the expense of other ecosystem values and services.
